If you are applying for (or renewing) a Standard Educator License you can add a coaching endorsement for no additional fee. To add a coaching endorsement at any other time, there is a \$50 fee.

Any educator who holds a
Head Coaching Endorsement in at least
one sport is also eligible to be an
Assistant Coach in ANY sport.



A Coaching Permit is for non-licensed individuals. If you hold a Standard Educator License, please see the endorsement requirements. If you do not meet the requirements, please see the Transitional Coaching Permit requirements.

Head Coach Requirements

- High School Diploma or High School Equivalency Certificate
- Current 1st Aid & CPR Training
- Care & Prevention of Athletic Injuries
- Foundations of Coaching
- Prior Coaching Experience OR Theory of the Specific Sport
- Developmental Psychology Course

In order to renew a Head Coach Permit, applicants are required to obtain five (5) continuing education credits every five (5) years.

Assistant Coaching Requirements

- High School Diploma or High School Equivalency Certificate
- Current 1st Aid & CPR Training
- Care & Prevention of Athletic Injuries
- Foundations of Coaching
- Prior Coaching Experience OR Theory of the Specific Sport

A Transitional Coaching Permit is issued when an applicant is unable to meet all of the requirements for a coaching endorsement or permit, but has been hired for a coaching position in a Wyoming school district.

- High School Diploma or High School Equivalency Certificate
- Current 1st Aid & CPR Training
- Care & Prevention of Athletic Injuries
- Verification of Employment in a Wyoming School District

Assistant Coaching Requirements

- High School Diploma or High School Equivalency Certificate
- · Current 1st Aid & CPR Training
- Verification of Employment in a Wyoming School District

Any applicant who is granted a transitional coaching permit will have THREE (3) years to complete ALL requirements. This is non-renewable.

Frequently Asked Questions

Do I have to submit fingerprints and the US/WY Constitution?

Yes. Every applicant is required to provide these two things unless the applicant currently holds a valid permit or license with PTSB. Once an applicant meets the US/WY Constitution requirement they do not need to do it again.

Do I need 1st Aid and CPR?

Yes. PTSB requires all coaches be certified in both areas.

Can I take an online 1st Aid/CPR course?

Applicants must either take a hands-on or hybrid (online and hands-on) 1st Aid/CPR course. PTSB cannot accept online-only courses.

Can I renew my Transitional Coaching Permit?

No. A Transitional Coaching Permit is valid for three (3) years ONLY. No extensions will be granted.

Can I send PTSB part of my application and the rest later?

No. Your application will be marked as incomplete and will not be processed unless we have a COMPLETE application.
