Our local banks have once again stepped up to help our students with our Banking Program. This is a program that provides our students an opportunity to learn the process of making deposits and reaping the benefits of saving. Due to COVID19 and our restrictions in our building, we will not be able to have deposits made here in the school – all deposits must be made at our banks. First Bank, Bank of Star Valley, and Advantage Credit Union are all participating again this year. If a student participates and makes weekly deposits into their account, at the end the participating banks will contribute \$\$ into their account.
